PER CURIAM:

his conviction Tyrone Powell appeals from possession with intent distribute powder cocaine, to violation of 21 U.S.C. §§ 841(a), 841(b)(1)(C) (2006). filed a motion to suppress evidence found during the search of his vehicle after an investigatory stop, and the district court denied the motion. On appeal, Powell argues the district court erred in denying his motion to suppress the evidence. court reviews the district court's factual findings underlying a motion to suppress for clear error and its legal conclusions de United States v. Day, 591 F.3d 679, 682 (4th Cir. 2010). We afford the district court's credibility determinations due deference, because "it is the role of the district court to observe witnesses and weigh their credibility during a pre-trial motion to suppress." United States v. Abu Ali, 528 F.3d 210, 232 (4th Cir. 2008) (internal quotation marks omitted), cert. denied, 129 S. Ct. 1312 (2009).

We have carefully reviewed the transcript of the hearing on Powell's motion and we conclude that, taken in the light most favorable to the Government, see <u>United States v. Matthews</u>, 591 F.3d 230, 234 (4th Cir. 2009), <u>petition for cert.</u> <u>filed</u>, __ U.S.L.W. __ (U.S. Apr. 23, 2010) (No. 09-10414), the evidence adduced at the hearing amply supports the district

court's ruling. Accordingly, we affirm the denial of Powell's motion to suppress and affirm the conviction.

We dispense with oral argument because the facts and legal contentions are adequately presented in the materials before the court and argument would not aid the decisional process.

AFFIRMED
