PER CURIAM:

Maria Delmis Marquez Guevara, a native and citizen of El Salvador, petitions for review of an order of the Board of Immigration Appeals (Board) dismissing her appeal from the Immigration Judge's denial of her requests for asylum and withholding of removal.^{*}

Marquez Guevara challenges the finding that her asylum is time-barred and that application no exceptions were applicable. See 8 U.S.C. § 1158(a)(2)(B) (2012); 8 C.F.R. § 1208.4(a)(2) (2016). We lack jurisdiction to review this determination pursuant to 8 U.S.C. § 1158(a)(3) (2012), and find that Marquez Guevara has not raised any claims that would fall under the exception set forth in 8 U.S.C. \S 1252(a)(2)(D) See Gomis v. Holder, 571 F.3d 353, 358-59 (4th Cir. (2012).2009). Accordingly, we dismiss the petition for review with respect to the asylum claim.

To the extent Marquez Guevara challenges the Board's finding that she failed to establish eligibility for withholding of removal, we conclude that the record evidence does not compel a ruling contrary to any of the agency's factual findings, <u>see</u> 8 U.S.C. § 1252(b)(4)(B) (2012), and that substantial evidence

supports the Board's decision, <u>INS v. Elias-Zacarias</u>, 502 U.S. 478, 481 (1992). Accordingly, we deny the petition for review in part for the reasons stated by the Board. <u>See In re Marquez</u> <u>Guevara</u> (B.I.A. Oct. 28, 2015). We dispense with oral argument because the facts and legal contentions are adequately presented in the materials before this court and argument would not aid the decisional process.
