PER CURIAM:

Piper Ann Rountree appeals the district court's orders denying relief on her civil action brought pursuant to 42 U.S.C. § 1983 (2012) and the Religious Land Use and Institutionalized Persons Act, 42 U.S.C. §§ 2000cc to 2000cc–5 (2012), and denying her motion to reconsider.
