Elsie M. Mayard appeals following the district court's adverse entry of judgment on a jury verdict in her 42 U.S.C. § 1983 action, and the court's subsequent

denial of her motion for a new trial under Federal Rule of Civil Procedure 59. Having reviewed the arguments raised in the Rule 59 motion, to the extent possible without a transcript of the three-day jury trial, this court finds no clear abuse of discretion in the district court's denial of the Rule 59 motion. *See Children's Broadcasting Corp. v. Walt Disney Co.*, 357 F.3d 860, 866-67 (8th Cir. 2004); *Schmid v. United Bhd. of Carpenters and Joiners of Am.*, 827 F.2d 384, 385-86 (8th Cir. 1987) (per curiam).² And having carefully reviewed the arguments for reversal raised in Mayard's brief, this court finds no other reversible error in these proceedings.
