DWYER, CLERK U.S. COURT OF APPEALS In their opening brief, petitioners fail to address, and thereby waive any challenge to, the agency's order denying their application for cancellation of removal. *See Martinez-Serrano v. INS*, 94 F.3d 1256, 1259-60 (9th Cir. 1996) (issues not specifically raised and argued in a party's opening brief are waived).

We lack jurisdiction to review the agency's denial of Barragan Avarca's request for voluntary departure. *See* 8 U.S.C. § 1229c(f); *Tovar-Landin v. Ashcroft*, 361 F.3d 1164, 1166 (9th Cir. 2004).
