Donye Maurice Sullivan appeals from his guilty-plea conviction and 24-month sentence for unauthorized use of access device obtain \$1,000 or more, in violation of 18 U.S.C. § 1029(a)(2). Pursuant to *Anders v. California*, 386 U.S.

738 (1967), Sullivan's counsel has filed a brief stating there are no grounds for relief, along with a motion to withdraw as counsel of record. We have provided the appellant with the opportunity to file a pro se supplemental brief. No pro se supplemental brief or answering brief has been filed.

Our independent review of the record pursuant to *Penson v. Ohio*, 488 U.S. 75, 80-81 (1988), discloses no arguable grounds for relief on direct appeal. We dismiss in light of the valid appeal waiver. *See United States v. Nguyen*, 235 F.3d 1179, 1182 (9th Cir. 2000).

Counsel's motion to withdraw is **GRANTED**.

**DISMISSED.**
