19 In accordance with the Order of Final Approval of Class Action Settlement ("Final  
20 Approval Order") entered by the Court in this action on June 27, 2008, it is

21 **ORDERED, ADJUDGED AND DECREED** that:

22 1. Judgment is hereby entered dismissing this action against defendant Lowe's  
23 Companies, Inc. on the merits and with prejudice and without the payment of costs other than as  
24 provided in the Stipulation of Settlement and Amendment thereto (collectively, the "Stipulation of  
25 Settlement") referred to in the Final Approval Order.

1           2.       Without affecting the finality of this Judgment in any way, the Court hereby retains  
2 continuing jurisdiction over (a) the implementation of the settlement as described in the  
3 Stipulation of Settlement, and (b) all parties hereto for the purpose of administering the Stipulation  
4 of Settlement and enforcing the terms of this Judgment.

5           3.       In the event the settlement does not become effective in accordance with the terms  
6 of the Stipulation of Settlement, then this Judgment shall be rendered null and void to the extent  
7 provided by and in accordance with the Stipulation of Settlement and shall be vacated and, in such  
8 event, all orders entered and releases delivered in connection herewith shall be null and void to the  
9 extent provided by and in accordance with the Stipulation of Settlement.
