**FINAL JUDGMENT BY CONSENT**

1           The Court, having considered the Stipulation Re Final Judgment and  
2 Permanent Injunction submitted by Plaintiff IMAX Corporation (“Plaintiff”), on the  
3 one hand, and Defendants Henrick Aghajanian, individually and d/b/a IMAX Auto  
4 Group, and IMAX Group Inc., individually and d/b/a IMAX Auto Group  
5 (collectively, “Defendants”), on the other hand, and good cause appearing  
6 therefore,

7           **HEREBY ORDERS, ADJUDGES AND DECREES:**

8           1.     Judgment is entered in favor of Plaintiff on all claims asserted by  
9 Plaintiff against Defendants in this Action.

10          2.     Defendants shall pay Plaintiff the sum of Three Thousand Five  
11 Hundred Dollars (\$3,500) within fifteen (15) days from entry by the Court of this  
12 [Proposed] Final Judgment By Consent.

13          3.     Defendants shall assign the URL <imaxautogroup.com> to Plaintiff no  
14 later than October 15, 2011, and from the date of entry of this [Proposed] Final  
15 Judgment By Consent through October 15, 2011, Defendants shall be permitted to  
16 use the URL <imaxautogroup.com> solely to redirect potential visitors to  
17 Defendants’ website accessible through the URL <imxautogroup.com>.

18          4.     The parties shall bear their own attorneys’ fees, expenses, and costs  
19 associated with the Action.

1           5.     No appeals shall be taken from the Final Judgment By Consent, and  
2 Plaintiff and Defendants hereby waive all right to appeal from the Final Judgment  
3 By Consent.
