("TYE") have compromised and settled the matters in dispute IT IS 3 HEREBY ORDERED, ADJUDICATED and DECREED as tollows: 4 5 **PERMANENT INJUNCTION ORDER** 6 Having considered the STIPULATION of the parties, and for good cause 7 shown, IT IS HEREBY ORDERED THAT: 8 1. NMC is a corporation organized and existing under the laws of the 9 State of California, having its principal place of business at 2755 Thompson Creek 10 Road, Pomona, California 91767. 11 2. TYE is a corporation organized and existing under the laws of the State 12 of California, having its principal place of business at 25841 Commercentre Drive, 13 Lake Forest, California 92630. 14 3. This Court has jurisdiction over the parties and the subject matter of 15 the Lawsuit. 16 4.
