1 **FINAL JUDGMENT**

2 The Court, having considered the Stipulated Judgment, and good cause
3 appearing:

4 **IT IS HEREBY ORDERED, ADJUDGED, AND DECREED AS**
5 **FOLLOWS:**

6 1. Judgment shall be entered in favor of Plaintiff Kawasaki Motors Finance
7 Corporation (“Plaintiff”) and against defendants Highland Tractor Motorsports, Inc., a
8 Texas corporation; Highland Tractor Motorsports, Inc., a Texas corporation doing
9 business as Humble Kawasaki; and, Keith Coble (collectively “Defendants”), jointly
10 and severally, in the amount of Five Hundred Seventy Five Thousand Dollars
11 (\$575,000.00) in full and final satisfaction of Plaintiff’s claims for: 1) Breach of
12 Contract; (2) Monies Lent/Book Account; and, (3) Breach of Written Continuing
13 Guaranties.

14 2. Plaintiff’s claim for Conversion against defendant Keith Coble is
15 dismissed without prejudice.
