2 Having granted Nominal Defendant Quiksilver, Inc.’s Motion to Dismiss,
3 and Individual Defendants Robert B. McKnight, Jr., William M. Barnum, Jr.,
4 Joseph F. Berardino, James G. Ellis, Charles S. Exon, M. Steven Langman, Robert
