10 19	Recommendations (ECF No. 14) that (1) Plaintiff's application for default judgment be

6	3.	Judgment shall be ENTERED in this action against in favor of Plaintiff and	
7		against Defendant;	
8	4.	Damages in the total amount of \$8,000 shall be AWARDED as follows:	
9		a. \$4,000 statutory damages for violation of 47 U.S.C. § 605;	
10		b. \$1,800 enhanced statutory damages for violation of 47 U.S.C. §	
11		605; and	
12		c. \$2,200 damages for the tort of conversion; and	
13	5.	The Clerk of Court is directed to close the case.
