

State court claim remanded on Oct. 24, 2001 (Kyle, J.); proceedings on federal claims stayed.

The Bankruptcy court granted in-part Jensen-Carter's motion for summary judgment. (Jan. 4, 2006)

Upheld grant of partial summary judgment to Jensen-Carter because Debtors have no valid claim to 875 Laurel, the fight is now between the trustees. 06-0693, 2007 WL 2885813 (Sept. 27, 2007) (Schiltz, J.) SEE ***

Filing restrictions placed on Stephens and Alexander.

Affirmed. No. 07-3342, 321 Fed. App'x 536 (8th Cir. Apr. 21, 2009) State District Court: Denied Stephens' motion for summary judgment and dismissed her counterclaims for lack of subject matter jurisdiction.

Interlocutory appeal. Affirmed. No. 02-1845, 2003 WL 21448791 (Minn. Ct. App. June 24, 2003)

State District Court: Stephens had a "homestead interest" in 875 Laurel and was entitled to immediate possession of the property. Expressly declined to address Alexander's purported transfer of the property. (January 27, 2004; April 29, 2004)

No. 01-0633 reopened Jan. 2005. Consolidated w/ 05-033

Denied Stephens' motion for summary judgment; remanded the purported removal and referred the DJ Complaint to the bankruptcy court Adv. No. 04-3468, Nos. 01-0633, 05-0033, 2005 WL 852446 (Apr. 11, 2005) (Magnuson, J.) (See *6.)

Appeal dismissed for lack of jurisdiction No. 05-2167, (8th Cir. May 20, 2005)
