**NON-PARTY CEDARCRESTONE,
 INC.'S MOTION TO SEAL PORTIONS
 OF ITS OPPOSITION TO PLAINTIFFS'
 RENEWED MOTION TO MODIFY
 PROTECTIVE ORDER**

19 Pursuant to the Stipulated Protective Order governing confidentiality of documents entered
 20 by the Court on May 21, 2010 [Dckt. No. 55] ("Protective Order"), Rule 5.2 and Rule 26(c) of the
 21 Federal Rules of Civil Procedure, and Local Rule 10-5, Non-party CedarCrestone Inc.
 22 ("CedarCrestone") respectfully requests that the Court order the Clerk to file under seal certain
 23 portions of CedarCrestone's Opposition ("Opposition") to Plaintiffs' renewed Motion to Modify
 24 Protective Order. Unredacted versions of the Opposition were lodged under seal on September 24,
 25 2012 [Dckt. No. 426]. Redacted versions of the Opposition were also publicly filed on the Court's
 26 ECF website on September 24, 2012 [Dckt. No.425]. The same information that is the subject of
 27 this Motion to Seal was previously ordered sealed by this Court [Dckt. No. 365] in connection with
 28 CedarCrestone's Opposition to Plaintiffs' first Motion to Modify Protective Order.

1 **MEMORANDUM OF POINTS AND AUTHORITIES**

2 The presumption of public access to court filings may be overcome by a showing of good
3 cause under Rule 26(c). See *Pintos v. Pacific Creditors Ass'n*, 605 F.3d 665, 678 (9th Cir. 2010).
4 The Court has broad latitude to prevent disclosure of materials for many types of information,
5 including, but not limited to, trade secrets or other confidential research, development, or
6 commercial information.” *Phillips v. Gen. Motors Corp.*, 307 F.3d 1206, 1211 (9th Cir. 2002).

7 Specifically, CedarCrestone requests that certain portions of its Opposition be sealed because
8 it contains highly sensitive, commercial information that may be harmful to the business interests of
9 CedarCrestone, a non-party to this lawsuit, and could and would be used by its competitors to the
10 detriment of CedarCrestone’s business. See, e.g., *Golden Boy Promotions, Inc. v. Top Rank, Inc.*,
11 2011 WL 686362, *2 (D.Nev. Feb. 17, 2011) (sealing records even though parties “failed to mention
12 specific harms that could occur” because information was not intended to be public but if disclosed
13 could cause business harm); *Stone v. Advance Amer., Cash Advance Centers, Inc.*, 2011 WL 662972,
14 *3 (S.D. Cal. Feb. 11, 2011) (sealing documents because they “might become a vehicle for improper
15 purposes in the hands of business competitors”).

16 The portions of the Opposition and Declaration to be sealed also constitute confidential
17 commercial information that, if produced, would be designated as “Highly Confidential-Attorney’s
18 Eyes Only” or “Confidential Information” pursuant to the Protective Order entered in this action.
19 See Protective Order, ¶¶3-4. The Protective Order provides that: “Counsel for any Designating
20 Party may designate any Discovery Material as ‘Confidential Information’ or ‘Highly Confidential
21 Information-Attorneys’ Eyes Only’ under the terms of this Protective Order only if such counsel in
22 good faith believes that such information and is subject to protection under Federal Rule of Civil
23 Procedure 26(c). The designation by any Designating Party of any Discovery Material as
24 ‘Confidential Information’ or ‘Highly Confidential Information-Attorneys’ Eyes Only’ shall
25 constitute a representation that an attorney for the Designating Party reasonably believes there is a
26 valid basis for such designation.” Protective Order, ¶2. The designating parties have represented
27 that good cause exists for sealing when identifying information under the Protective Order as
28 “Confidential” or “Highly Confidential-Attorneys Eyes Only.” This is a sufficient showing of good

1 cause to permit a sealing order on a non-dispositive motion. *See, e.g., Pacific Gas and Elec. Co. v.*
2 *Lynch*, 216 F.Supp.2d 1016, 1027 (N.D. Cal. 2002).

3 Further, all the same information to be sealed that is the subject of this Opposition to
4 Plaintiffs' renewed Motion to Modify Protective Order has previously been ordered sealed by this
5 Court [Dckt No. 365] in connection with CedarCrestone's Opposition to Plaintiffs' first Motion to
6 Modify Protective Order.

7 CedarCrestone's request for a sealing order has been narrowly tailored. CedarCrestone has
8 prepared and filed redacted versions for the Court's public files that allows public access to the
9 filings except those portions sealed, and seeks to protect only those portions of the Opposition and
10 Declaration that, if produced, would be designated as either "Highly Confidential-Attorney's Eyes
11 Only" or "Confidential Information" under the Protective Order entered in this action, and that could
12 be used by CedarCrestone's competitors to cause further harm to CedarCrestone.

13 For the foregoing reasons, CedarCrestone respectfully requests that the Court grant its
14 Motion to Seal for good cause shown.



19 Pending before this Court is Non-party CedarCrestone, Inc.'s ("CedarCrestone's") Motion to
20 Seal Portions of its Opposition [Redacted Opposition-Dckt. No. 425; Unredacted Opposition filed
21 under seal-Dckt. No. 426] to Plaintiffs' renewed Motion to Modify Protective Order [Renewed
22 Motion-Dckt. No. 385]. This same information was previously ordered sealed by this Court in
23 connection with Cedar Crestone's Opposition to Plaintiffs' first Motion to Modify Protective Order
24 [Prior Court Order Sealing Same Information-Dckt. No. 365]. Federal Rule of Civil Procedure
25 26(c) provides broad discretion for a trial court to permit sealing of court documents for, *inter alia*,
26 the protection of "trade secret or other confidential research, development, or commercial
27 information." Fed. R. Civ. P. 26(c). Having considered Non-party CedarCrestone, Inc.'s Motion to
28 Seal, compelling reasons having been shown and good cause existing:
