1 **DECLARATION OF SOPHIA A. ROMERO IN SUPPORT OF MOTION TO**
2 **WITHDRAW AS COUNSEL OF RECORD AND REMOVAL FROM CM/ECF SERVICE**
3 **LIST**

4 I, SOPHIA A. ROMERO, ESQ., declare under penalty of perjury under the laws of the United
5 States, as follows:

6 1. I am an attorney, duly licensed to practice in all courts in the State of Nevada, and am an
7 attorney of the law firm MAIER GUTIERREZ & ASSOCIATES, attorneys of record for Plaintiff Damon
8 L. Campbell. The facts set forth in this declaration are known to me personally, or are based upon
9 my information and belief, and if called to do so, I would competently testify under oath regarding
10 the same.

11 2. I make this declaration in support of my law firm's motion to withdraw as counsel of
12 record and removal from CM/ECF service list for Defendants.

13 3. Plaintiff retained my law firm to represent him in the above-captioned matter on or about
14 July 5, 2023.

15 4. On August 14, 2023, the United States District Court for the District of Nevada entered
16 a judgment in favor of Defendants, Dean Willett et al., and against Plaintiff Damon L. Campbell.
17 **Exhibit 1**, Order Granting Defendants' Motion for Summary Judgment and Denying Plaintiff's
18 Motion for Summary Judgment.

19 5. On August 21, 2021, plaintiff and I mutually agreed to terminate the attorney-client
20 relationship between Damon L. Campbell, and MAIER GUTIERREZ & ASSOCIATES, whether this case
21 gets refiled, appealed, or for any other reason.

22 6. Because this case is instructed to enter judgment in favor of the defendants and against
23 the plaintiff, and to close this case, no delay of discovery, the trial, or any hearing in the case will
24 result. Accordingly, withdrawal can be accomplished pursuant to LR IA11-6(b) without material
25 adverse effect on the interests of Plaintiff.

26 7. Plaintiff's last known address is as follows: Ely State Prison, P.O. Box 1989, Ely, NV
27 89301.

28 8. A copy of this motion has been served on the Plaintiff via certified mail, return receipt

1 requested, as well as via the Court's CM/ECF system to all parties and counsel as identified on the
2 Court-generated Notice of Electronic Filing.

3 9. Accordingly, the law firm MAIER GUTIERREZ & ASSOCIATES respectfully requests that the
4 Court grant this motion and enter an order allowing the law firm to withdraw as attorneys of record
5 for the Plaintiff in this matter.

6 I declare under penalty of perjury under the laws of the state of Nevada that the foregoing
7 statement is true and correct to the best of my knowledge, information and belief.

11 **MEMORANDUM OF POINTS AND AUTHORITIES**

12 **I. FACTS**

13 Counsel for plaintiff received notice of this matter through the pro bono project at Legal Aid
14 Center of Southern Nevada. At the time of counsel's appearance, discovery was closed and the Court
15 was considering cross-motions for summary judgment. On August 14, 2023, the Court issued an
16 order in favor of defendants and against plaintiff.

17 **II. MOTION TO WITHDRAW AS COUNSEL**

18 S.C.R. 46 provides in pertinent part:

19 After judgment or final determination, an attorney may withdraw as attorney
20 of record at any time upon the attorney's filing a withdrawal, with or without
the client's consent.

21 R.P.C. 1.16 provides in pertinent part:

22 (b) A lawyer may withdraw from representing a client if: (1) Withdrawal can
23 be accomplished without material adverse effect on the interests of the client...
or (7) Other good cause for withdrawal exists.

24 (c) A lawyer must comply with applicable law requiring notice to or permission
25 of a tribunal when terminating representation. When ordered to do so by a
26 tribunal, a lawyer shall continue representation notwithstanding good cause for
terminating the representation.

27 (d) Upon termination of representation, a lawyer shall take steps to the extent
28 reasonably practicable to protect a client's interests, such as giving reasonable
notice to the client, allowing time for employment of other counsel,
surrendering papers and property to which the client is entitled and refunding

1 any advance payment of fee or expense that has not been earned or incurred.
2 The lawyer may retain papers relating to the client to the extent permitted by
3 other law.

LR IA 11-6 provides in pertinent part:

4 (b) If an attorney seeks to withdraw after appearing in a case, the attorney must
5 file a motion or stipulation and serve it on the affected client and opposing
6 counsel. The affected client may, but is not required to, file a response to the
7 attorney’s motion within 14 days of the filing of the motion, unless the court
8 orders otherwise.

9 ...
10 (e) Except for good cause shown, no withdrawal . . . will be approved if it will
11 result in delay of discovery, the trial, or any hearing in the case.

12 As outlined in the declaration of counsel and facts above, on August 14, 2023, the United
13 States District Court for the District of Nevada entered a judgment in favor of Defendants, Dean
14 Willett et al., and against Plaintiff Damon L. Campbell, Order Granting Defendants’ Motion for
15 Summary Judgment and Denying Plaintiff’s Motion for Summary Judgment. Ex. 1. Plaintiff and
16 MAIER GUTIERREZ & ASSOCIATES mutually agreed to terminate the attorney-client relationship
17 between Plaintiff Damon L. Campbell, and MAIER GUTIERREZ & ASSOCIATES.

18 Plaintiff’s attorneys have taken affirmative steps to protect the interests of plaintiff. As stated
19 above, plaintiff’s counsel contacted plaintiff wherein plaintiff consented to the withdrawal of counsel
20 and agreed that in the event an appeal is filed, MAIER GUTIERREZ & ASSOCIATES will no longer be
21 counsel for plaintiff and will have no further obligations to defendants. Because this case was
22 instructed to enter judgment in favor of the defendants and against the plaintiff, and to close this case,
23 no delay of discovery, the trial, or any hearing in the case will result. Therefore, withdrawal of MAIER
24 GUTIERREZ & ASSOCIATES will not adversely affect the interests of Plaintiff.

25 Pursuant to LR IA 11-6(b), a copy of this motion has been served on the Plaintiff via certified
26 mail, return receipt requested, as well as via the Court’s CM/ECF system to all parties and counsel
27 as identified on the Court-generated Notice of Electronic Filing.
