 and transfer of at least forty-five related putative class action complaints. The JPML heard oral
 arguments on the Motion on January 25, 2024.
 Defendants' individual responses are currently due by January 29, 2024.

This extension is necessary to allow the JPML sufficient time to evaluate the various related
actions, twenty-one of which have been filed in this District alone. A list of these related actions is
