Before the Court is the Report and Recommendation of the Magistrate Judge filed July 26, 2012 in the above-entitled action. On August 9, 2012 Defendant Commissioner of Social Security filed a response indicating there would be no objection to the Report and Recommendation. (Doc. No. 17). Under the relevant statute:

Within ten days after being served with a copy, any party may serve and file written objections to such proposed findings and recommendations as provided by rules of court. A judge of the court shall make a de novo determination of those portions of the report or specified proposed findings or recommendations to which objection is made.

28 U.S.C. § 636(b)(1)(C) (1982). In this case, the ten-day period has elapsed and no objections have been filed. The failure to file written objections to a Magistrate Judge's report and recommendation constitutes a waiver of a <u>de novo</u> determination by the district court of an issue covered in the report. <u>Thomas v. Arn</u>, 728 F.2d 813 (6th Cir. 1984) <u>affirmed</u>, 474 U.S. 140 (1985); <u>see United States v. Walters</u>, 638 F.2d 947 (6th Cir. 1981).

The Court has reviewed the Magistrate Judge's Report and Recommendation, and adopts that Report and Recommendation in its entirety. The final decision of the Commissioner is reversed and this case remanded for further proceedings in accordance with the Report and Recommendation.
