PER CURIAM

Travis Lucas appeals the trial court's order summarily denying his rule 3.850 motion for postconviction relief as improperly successive. After considering the unique procedural history of this case, we conclude that good cause existed to allow the successive filing. <u>See</u> Fla. R. Crim. P. 3.850(h)(2). Accordingly, we reverse the order of the trial court and remand for consideration on the merits.
