PER CURIAM.

Tina Marie Rakoski appeals her sentence and the denial of her motion to correct sentence. We affirm without discussion, except as to condition number 30 of Rakoski's community control order. section 945.26, Florida Statutes (1977), which in turn was repealed in 1985. See Ch. 85-288 § 27, Laws of Fla.
