Upon review of the statements supporting and contesting jurisdiction and the record, it appears that the circuit court's March 9, 2005 order granting summary judgment on the complaint was not reduced to a separate judgment, as required by HRCP 58.

See Jenkins v. Cades Schutte Fleming & Wright, 76 Hawai'i 115, 869 P.2d 1334 (1994) (an order that resolves claims in a circuit court civil case is not appealable unless the order is reduced to a separate judgment pursuant to HRCP 58). Thus, the appeal of the March 9, 2005 order is premature and we lack jurisdiction. Therefore,
