THE COURT:

It is ordered that the opinion filed herein on November 2, 2010 be modified as follows:

On page 66, in the last paragraph and at the end of the first sentence, the following footnote is added after the words "attorneys' fees in addition to other costs." The footnote will become footnote 26, which will require renumbering of all subsequent footnotes.

Civil Code section 1717, subdivision (a) also states: "Where a contract provides for attorney's fees, as set forth above, that provision shall be construed as applying to *the entire contract*, unless each party was represented by counsel in the negotiation and execution of the contract, and the fact of that representation is specified in the contract." Neither party raises an argument about this portion of the statute on appeal. We therefore express no opinion with respect to the potential applicability of this portion of the statute to the issues in this cases.

There is no change in the judgment.
