
The “officially released” date that appears near the beginning of each opinion is the date the opinion will be published in the Connecticut Law Journal or the date it was released as a slip opinion. STATE *v.* HERRING—SECOND CONCURRENCE

PALMER, J., with whom McDONALD, J., joins, concurring. I continue to adhere to the views expressed in my concurrence in *State v. Bellamy*, 323 Conn. 400, 466, 2016 WL 1000 (2016), with respect to the law of implied waiver as applied to jury instruction claims. Under the unique circumstances and for the limited purpose of the present case, however, I concur with and join the majority opinion.
