(1) The defendants-appellants, F. Tropea Building Contractor, LLC, and Holiday Park, LLC (the "appellants"), have petitioned this Court, pursuant to Supreme Court Rule 42, to accept an appeal from the interlocutory order of the Superior Court dated June 4, 2010, which opened the judgment of the Superior Court in C.A.
