**ORDER**

After careful consideration of the appellant’s opening brief, the State’s motion to affirm, and the record on appeal, we conclude that the judgment below should be affirmed on the basis of the Superior Court’s order, dated March 4, 2020 and docketed March 6, 2020, denying the appellant’s fourth motion for postconviction relief as procedurally barred. As the Superior Court observed, the appellant has not pleaded any circumstances under Rule 61(d)(2)(i) or (d)(2)(ii) that overcome the procedural bars set forth in Rule 61,<sup>1</sup> nor does he claim that the Superior Court lacked jurisdiction.<sup>2</sup>
