independent review of the entire record reveals that counsel's assessment of the relative merit of the appeal is correct. Because independent examination of the entire record reveals no arguable issues of merit, counsel's motion to withdraw is GRANTED, and Eloi's convictions and sentences are AFFIRMED. All pending motions are DENIED as moot.¹

¹ We acknowledge that Eloi expressed dissatisfaction with trial counsel's performance and that he might wish to argue that his counsel was ineffective. Such claims, however, generally "are not considered for the first time on direct appeal," but rather are best reserved for postconviction proceedings. *United States v. Tyndale*, 209 F. 3d 1292, 1294 (11th Cir. 2000); *see Massaro v. United States*, 538 U.S. 500, 504-05 (2003).
