PER CURIAM:

Claudia Hirmer, a federal prisoner, appeals *pro se* the denial of her motion to access grand jury transcripts. Hirmer sought to use the transcripts to prepare an application for a certificate of appealability, which we have since denied. And we have denied her motion for reconsideration of that order. Because “we can no longer offer [Hirmer] any effectual relief,” *Gagliardi v. TJC Land Tr.*, 889 F.3d 728, 733 (11th Cir. 2018), we dismiss her appeal as moot.
