## PER CURIAM:

This appeal is DISMISSED, *sua sponte*, for lack of jurisdiction. Shawn Chalifoux appeals directly from a magistrate judge's order committing him to the custody of the Attorney General for competency restoration treatment. However, we lack jurisdiction to directly review the magistrate judge's order, as it must first be challenged in, and rendered final by, the district court. *See* 28 U.S.C. § 1291; *Donovan v. Sarasota Concrete Co.*, 693 F.2d 1061, 1066-67 (11th Cir. 1982) (explaining that magistrate judge orders issued pursuant to 28 U.S.C. § 636(b) are not final and may not be appealed until rendered final by a district court); *United States v. Schultz*, 565 F.3d 1353, 1359 (11th Cir. 2009) (noting that appellate courts are without jurisdiction to hear appeals directly from magistrate judges).

No petition for rehearing may be filed unless it complies with the timing and other requirements of 11th Cir. R. 40-3 and all other applicable rules.
