PER CURIAM:

Joseph Grayson Ward appeals the district court's order accepting the recommendation of the magistrate judge and denying relief on his 42 U.S.C. § 1983 (2000) complaint.\* We have reviewed the record and find no reversible error. Accordingly, we affirm for the reasons stated by the district court. Ward v. Beaufort County Det. Ctr., No. 2:04-cv-00792-RBH (D.S.C. May 18, 2007). \*In his informal brief and informal reply brief, Ward asserts error only in the district court's denial of relief on his claims against defendants Beaufort County Detention Center and Mark Fitzgibbons.
