Felix Oriakhi seeks to appeal the district court's order construing his "Petition for Writ of Audita Querela" as a motion pursuant to 28 U.S.C. § 2255 (2000), and denying it for failure to first obtain authorization from this court to file a successive § 2255 motion. See 28 U.S.C. §§ 2244(b)(2), 2255 He also seeks to appeal the district court's order (2006).denying his Fed. R. Civ. P. 59(e) motion. The orders are not appealable unless a circuit justice or judqe issues certificate of appealability. 28 U.S.C. § 2253(c)(1) (2000). Α appealability will certificate of not issue absent substantial showing of the denial of a constitutional right." 28 U.S.C. § 2253(c)(2) (2000). A prisoner satisfies this standard by demonstrating that reasonable jurists would find that any assessment of the constitutional claims by the district court is debatable or wrong and that any dispositive procedural ruling by the district court is likewise debatable. Miller-El v. Cockrell, 537 U.S. 322, 336-38 (2003); Slack v. McDaniel, 529 U.S. 473, 484 (2000); Rose v. Lee, 252 F.3d 676, 683-84 (4th Cir. 2001). We have independently reviewed the record and has not made the requisite showing. conclude that Oriakhi Accordingly, we deny a certificate of appealability, deny Oriakhi's motion to consolidate, and dismiss the appeal. dispense with oral argument because the facts and legal

contentions are adequately presented in the materials before the court and argument would not aid the decisional process.
