PER CURIAM:

In these consolidated appeals, Andrew D. Wenmoth appeals the district court's orders accepting the recommendation of the magistrate judge and denying relief on his 42 U.S.C. § 1983 (2006) complaint. We have reviewed the record and find no reversible error. Accordingly, we deny Wenmoth's motion for appointment of counsel and affirm for the reasons stated by the district court. Wenmoth v.
