PER CURIAM:

Kevin A. Rideout seeks to appeal the district court's orders accepting the recommendation of the magistrate judge and denying relief on his 28 U.S.C.A. § 2255 (West Supp. 2009) motion and denying his motion to reconsider. The order is not a circuit justice or appealable unless judge issues а certificate of appealability. 28 U.S.C. § 2253(c)(1) (2006). Α certificate appealability will not issue of absent "a substantial showing of the denial of a constitutional right." A prisoner satisfies 28 U.S.C. § 2253(c)(2) (2006). this standard by demonstrating that reasonable jurists would find that any assessment of the constitutional claims by the district court is debatable or wrong and that any dispositive procedural ruling by the district court is likewise debatable. Miller-El v. Cockrell, 537 U.S. 322, 336-38 (2003); Slack v. McDaniel, 529 U.S. 473, 484 (2000); Rose v. Lee, 252 F.3d 676, 683-84 (4th Cir. 2001). We have independently reviewed the record and conclude that Rideout has not made the requisite showing. Accordingly, we deny a certificate of appealability and dismiss the appeal. We dispense with oral argument because the facts and legal contentions are adequately presented in the materials before the court and argument would not aid the decisional process.
