PER CURIAM:

Rosario A. Fiorani, Jr., appeals the district court's order accepting the magistrate judge's recommendation and dismissing Fiorani's civil complaint pursuant to 28 U.S.C. § 1915(e)(2)(B)(ii) (2006) for failure to state a claim.
