## PER CURIAM:

Juan Garcia appeals the district court's order denying dismiss the indictment charging his motion to him possession of a prohibited object, in violation of 18 U.S.C. § 1791(a)(2) (2006).\* He asserts that the Double Jeopardy Clause protects him from being indicted for the same misconduct that resulted in his placement in prison disciplinary segregation. We have previously rejected this argument. Patterson v. United States, 183 F.2d 327, 328 (4th Cir. 1950); see United States v. Simpson, 546 F.3d 394, 398 (6th Cir. 2008) (en banc) (collecting cases and holding that "[t]he Double Jeopardy Clause was not intended to inhibit prison discipline, and disciplinary changes in prison conditions do not preclude subsequent criminal punishment for the same misconduct"); United States v. Brown, 59 F.3d 102, 103-04 (9th Cir. 1995) (same).

Accordingly, we affirm the district court's order. We dispense with oral argument because the facts and legal contentions are adequately presented in the materials before the court and argument would not aid the decisional process.

AFFIRMED
