PER CURIAM:

Mykal S. Ryan, Helen E. Ryan, and John J. Ryan, Jr., the district court's order appeal from accepting the recommendation of the bankruptcy judge, granting the bankruptcy trustee's motion for default judgment, authorizing the trustee to avoid certain transfers to the Ryans, and entering monetary judgments in favor of the trustee. We have reviewed the record and find no reversible error. Accordingly, we affirm for the reasons stated by the district court. Ruby v. Ryan, 4:12-cv-00157-MSD-TEM (E.D. Va. Aug. 14, 2013). We dispense with oral argument because the facts and legal contentions are adequately presented in the materials before this court and argument would not aid the decisional process.
