PER CURIAM:

Quintin Littlejohn appeals the district court's order dismissing his civil action without prejudice and without service of process. The district court referred this case to a magistrate judge pursuant to 28 U.S.C. § 636(b)(1)(B) (2012). The magistrate judge recommended that the complaint be dismissed and advised Littlejohn that failure to file specific, timely objections to this recommendation could waive appellate review of a district court order based upon the recommendation.

The timely filing of specific objections to а magistrate judge's recommendation is necessary to preserve appellate review of the substance of that recommendation when parties have been warned of the the consequences of Wright v. Collins, 766 F.2d 841, 845-46 (4th noncompliance. Cir. 1985); see also Thomas v. Arn, 474 U.S. 140 (1985). Littlejohn has waived appellate review by failing to file specific objections after receiving proper notice. Accordingly, we affirm the judgment of the district court.

We dispense with oral argument because the facts and legal contentions are adequately presented in the materials before this court and argument would not aid the decisional process.
