PER CURIAM:

P.H. Harrington, Jr., appeals from the district court orders determining that Harrington's claim asserted in Mary D. Slaey's bankruptcy case was barred by the statute of limitations, and denying reconsideration of that order. We have reviewed the record and the arguments presented on appeal and find no reversible error. Accordingly, we affirm for the reasons stated by the district court. Harrington v.
