PER CURIAM:

Christie Wyatt appeals from the jury's verdict in favor of IPKeys Technologies, LLC, on her claim that she was terminated in violation of the Uniformed Services Employment and Reemployment Rights Act, 38 U.S.C. § 4311 (2012). We have considered Wyatt's arguments and reviewed the district court record and discern no reversible error. Accordingly, we affirm the district court's judgment. Wyatt v.
