PER CURIAM:

Christopher Antonio Davis appeals the district court's order denying his motion for a reduction of sentence pursuant to 18 U.S.C. § 3582(c)(2) (2012). We generally review an order denying a § 3582(c)(2) motion for abuse of discretion. See United States v. Goines, 357 F.3d 469, 478 (4th Cir. 2004). We review de novo, however, a district court's determination of the scope of its authority under § 3582(c)(2). United States v. Dunphy, 551 F.3d 247, 250 (4th Cir. 2009). Based on our review of the record and the relevant legal authorities, we conclude that the district court did not err in denying Davis' motion for a sentence reduction. We therefore affirm the district court's We deny Davis' motion for appointment of counsel and order. facts and legal dispense with oral argument because the contentions are adequately presented in the materials before this court and argument would not aid the decisional process.
