PER CURIAM:

Casey Lynn Jordan appeals the district court's order granting summary judgment to Allstate Insurance Company on her claims alleging bad faith refusal to pay, bad faith handling/adjusting her claim, and breach of contract. We have reviewed the record included on appeal, as well as the parties' briefs, and we find no reversible error. Accordingly, we affirm for the reasons stated by the district court. Jordan v. Allstate Ins. Co., No. 4:14-cv-03007-RBH (D.S.C. Aug. 16, 2016).
