Appealing the Judgment in a Criminal Case, Hugo Alexander Bermudes-Cruz presents arguments that he concedes are foreclosed by Almendarez-Torres v. United States, 523 U.S. 224, 235 (1998), which held that 8 U.S.C. § 1326(b)(2) is a penalty provision and not a separate criminal offense, and by United States v. Mendoza-Sanchez, 456 F.3d 479, 483 (5th Cir. 2006), which held that the district court may use all facts admitted by the defendant in determining whether the prior conviction qualifies as an enumerated offense under U.S.S.G. § 2L1.2. The Government's
