The attorney appointed to represent Juan Gonzales Rios, Jr., has moved for leave to withdraw and has filed a brief in accordance with *Anders v*. *California*, 386 U.S. 738 (1967). Rios has filed a response. The record is insufficiently developed to allow consideration at this time of Rios's claim of ineffective assistance of counsel; such claims generally "cannot be resolved on direct appeal when [they have] not been raised before the district court since no opportunity existed to develop the record on the merits of the allegations."
