The attorney appointed to represent Christina Elizabeth Griego has moved for leave to withdraw and has filed a brief in accordance with *Anders v. California*, 386 U.S. 738 (1967), and *United States v. Flores*, 632 F.3d 229 (5th Cir. 2011). Griego has not filed a response. We have reviewed counsel's

brief and the relevant portions of the record reflected therein. We concur with counsel's assessment that the appeal presents no nonfrivolous issue for appellate review.¹ Accordingly, counsel's motion for leave to withdraw is GRANTED, counsel is excused from further responsibilities herein, and the APPEAL IS DISMISSED. *See* 5TH CIR. R. 42.2.

¹ Although counsel's brief relies in part on the appeal waiver in Griego's plea agreement, we agree with the remainder of counsel's analysis, which shows that there is no nonfrivolous issue for appeal regardless of whether the appeal waiver is enforced. However, for future cases, counsel is reminded of her obligation to "ascertain and certify that the Government would rely on the defendant's appellate waiver before moving to withdraw" on that basis. *United States v. Acquaye*, 452 F.3d 380, 382 (5th Cir. 2006).
