PER CURIAM:*

Ruben Hernandez-Correa appeals his conviction for illegal reentry and his sentence of 30 months of imprisonment and three years of supervised release. He argues for the first time on appeal that his sentence exceeds the

statutory maximum because the enhanced penalty provisions of 8 U.S.C. § 1326(b) are unconstitutional.

Hernandez-Correa has filed an unopposed motion for summary disposition and a letter brief correctly conceding that this issue is foreclosed by *Almendarez-Torres v. United States*, 523 U.S. 224 (1998). *See United States v. Pervis*, 937 F.3d 546, 553-54 (5th Cir. 2019). He states that he raises the issue only to preserve it for possible further review. Because summary disposition is appropriate, *see Groendyke Transp.*, *Inc. v. Davis*, 406 F.2d 1158, 1162 (5th Cir. 1969), Hernandez-Correa's motion is GRANTED, and the district court's judgment is AFFIRMED.
