SARGUS, District Judge. The Appellant, Nolan Whitaker (“Whitaker”), appeals the summary judgment rendered by the district court in favor of the Appellee, Electronic Data Systems Corporation (“Electronic Data”). Whitaker contends that his former employer, Electronic Data, retaliated against him for asserting his rights under the Family Medical Leave Act (“FMLA”), 29 U.S.C. § 2601, *et. seq.*, interfered with his rights under the FMLA, and discriminated against him in violation of the Kentucky Civil Rights Act, Ky. Rev. Stat.
