**PER CURIAM.** Plaintiff Joyce Brown appeals the district court's award of summary judgment to defendant law enforcement officers on her civil rights and tort claims stemming from two encounters in August and December 2009. Having duly considered the district court's opinion and the record in light of the parties' appellate briefing, we find that plaintiff has not raised any argument that is not fairly and properly addressed in the district court's opinion.
