Iowa civil detainee John W. Arnzen, III appeals the district court's¹ preservice dismissal of his 42 U.S.C. § 1983 action challenging his commitment to the Civil Commitment Unit for Sex Offenders, and arguing he should have been released on supervision. Having jurisdiction under 28 U.S.C. § 1291, this court affirms.

This court finds no reversible error upon de novo review. *See Moore v. Sims*, 200 F.3d 1170, 1171 (8th Cir. 2000) (per curiam). The district court did not abuse its discretion in denying appointed counsel. *See Phillips v. Jasper Cty. Jail*, 437 F.3d 791, 794 (8th Cir. 2006) (no right to appointed counsel in civil cases).

The judgment is affirmed. See 8th Cir. R. 47B.
