2. The state's Petition for Rehearing is due on October 4, 2010. The state seeks a 35-day extension until November 8, 2010, in which to file its Petition for Rehearing. This is the first request for a time extension.

3. This extension is requested to allow adequate time for counsel to analyze the panel decision, which finds two Oregon criminal statutes facially unconstitutional and thus addresses an important issue of state law. Time is needed to allow necessary internal discussion about whether a petition for rehearing/rehearing en banc should be filed and, if so, on what specific grounds. In addition to the Attorney General, the named defendants in this case include all the state's district attorneys. Because of the complexity of the case, the importance of the issues, and the number of interested parties, I anticipate that these discussions will take three to four weeks to complete.

4. In addition, I have been, and will be, occupied completing the briefing in a number of other cases, including the board's brief in *Mathews v. Elevator Board*, Oregon Court of Appeals Case No. A145611 (filed September 16, 2010), the board's brief in *Homestyle Services v. Department of Human Services*, Oregon Court of Appeals Case No. A145136 (due October 4, 2010), the state's opening brief in the Oregon Supreme Court in *Sierra v. State*, Oregon Supreme Court Case No. S057794 (due October 15, 2010), the state's brief in *State v. Lewis*, Oregon Court of Appeals Case No. A142643 (due

October 22, 2010), the state's brief in *State v. Dries*, Oregon Court of Appeals No. A142715 (due on November 2, 2010), the state's brief in *State v. Baker*, Oregon Court of Appeals No. A141667 (due November 3, 2010), and the state's brief in *State v. Olson*, Oregon Court of Appeals No. A142327 (due November 3, 2010).

5. The state's attorneys have exercised due diligence and I anticipate that the state will file its Petition for Rehearing within the time sought.


