**APPELLANT’S MOTION TO FILE
ITS OPENING BRIEF AND

Pursuant to Interim Circuit Rule 27-13(e), Defendant-Appellant VidAngel, Inc. (“VidAngel”) hereby moves to seal portions of the contemporaneously filed Appellant’s Opening Brief (the “Brief”), as well as Volume V of the contemporaneously filed Excerpts of Record.
