Duane Thomas Lee appeals from the district court's judgment denying his 28 U.S.C. § 2255 motion to vacate his conviction under 18 U.S.C.

§ 924(c)(1)(A)(iii) for discharging a firearm during the commission of a crime of violence. Pursuant to *Anders v. California*, 386 U.S. 738 (1967), Lee's counsel has

filed a brief stating that there are no grounds for relief, along with a motion to withdraw as counsel of record. We have provided Lee the opportunity to file a prose supplemental brief. No prose supplemental brief or answering brief has been filed.

Our independent review of the record pursuant to *Penson v. Ohio*, 488 U.S. 75, 80-81 (1988), discloses that the certified issues provide no basis for appellate relief. *See Graves v. McEwen*, 731 F.3d 876, 880-81 (9th Cir. 2013); *see also United States v. Begay*, 33 F.4th 1081, 1093-96 (9th Cir.) (en banc), *cert. denied*, 143 S. Ct. 340 (2022).

Counsel's motion to withdraw is GRANTED.
