PER CURIAM.

Deborah Blanchard Oduwa seeks review of an order of the United States Court of Federal Claims dismissing her complaint for lack of subject matter jurisdiction. <u>Oduwa v. United States</u>, No. 06-CV-88 (Fed. Cl. Feb. 23, 2006). We <u>affirm</u>.

Whether the Court of Federal Claims properly dismissed Oduwa's complaint for lack of jurisdiction is a question of law that we review <u>de novo</u>. <u>Wilson v. United States</u>,

405 F.3d 1002, 1008 (Fed. Cir. 2005). The Court of Federal Claims has authority to issue judgments against the United States only where the claims are grounded in a contract with the United States or arise under a money-mandating statute, regulation, or provision of the Constitution. 28 U.S.C. § 1491; <u>United States v. Testan</u>, 424 U.S. 392, 397 (1976). It does not have jurisdiction over claims sounding in tort. 28 U.S.C. § 1491(a)(1); <u>Brown v. United States</u>, 105 F.3d 621, 623 (Fed. Cir. 1997). None of Oduwa's claims flow from a contract or arise under a money-mandating statute, regulation, or provision of the Constitution, and all of her claims are based upon alleged negligent or intentional wrong-doing by the government. They sound in tort, and the trial court properly dismissed her complaint for lack of subject matter jurisdiction.
